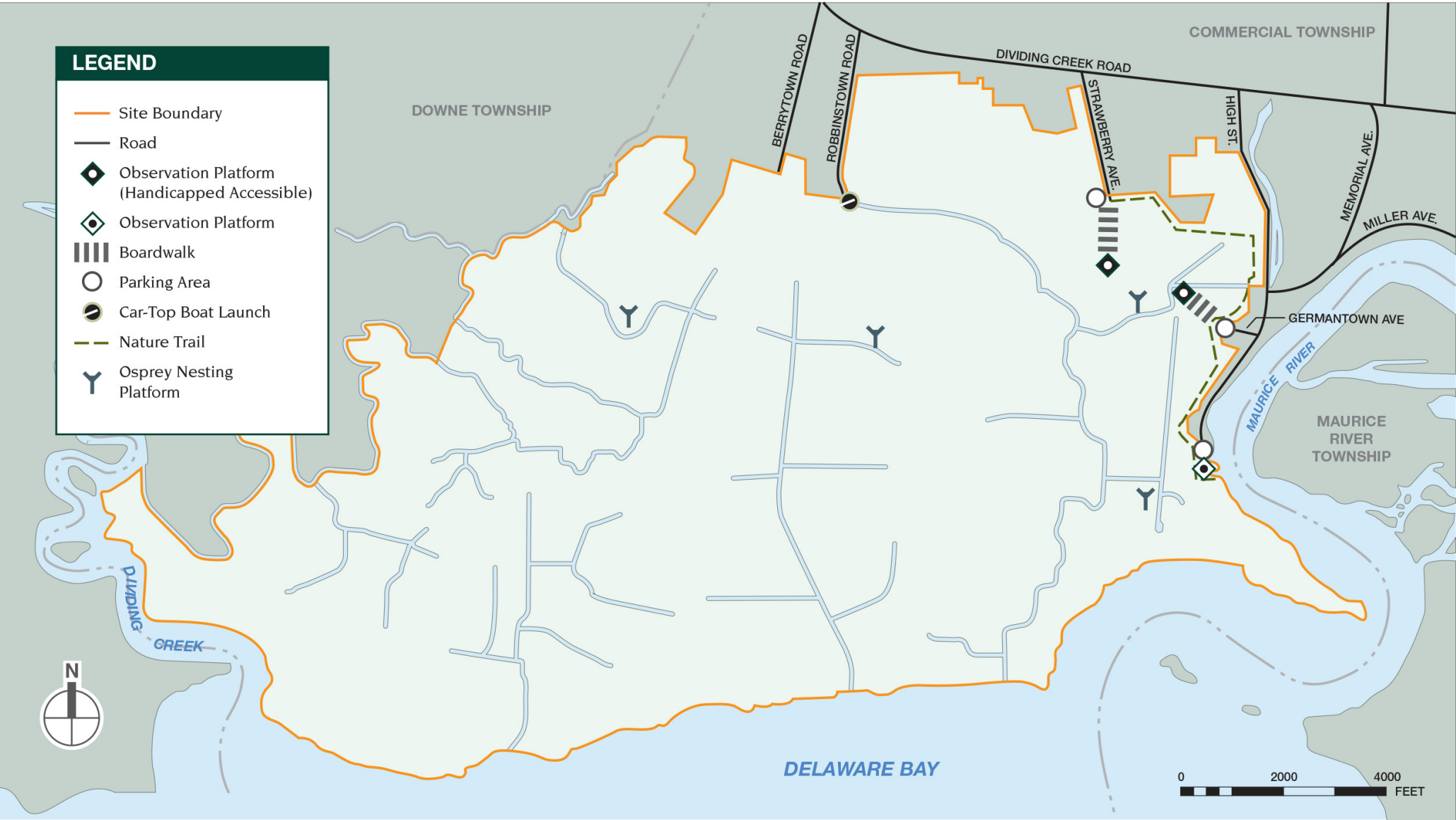
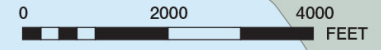

Site Use Rules (New Jersey Sites)

- Hours of Use: Most sites are open for public use from dawn to dusk (see exceptions below). Special event/use permits may be available for public events, group events and some after-hours educational/club activities (e.g., astronomy club).
 - Alloway Creek Watershed Wetland Restoration Site Hours of Use:
Elsinboro Point Parking Area:
March 1 – April 30, 6AM to 7PM
May 1 – September 30, 6AM to 8PM
October 1 – February 29, 7AM to 5PM
 - Bayside Tract Hours of Use:
Year Round, 5AM to 9PM
- Parking is prohibited on all PSEG lands except in designated parking areas. Rules for PSEG lands, as posted in parking areas, *will be enforced*. Parking areas are considered closed to further public use/access when parking spaces are filled.
- Use of motorized vehicles is restricted to public roadways. Motorized off-road vehicles are prohibited within the boundaries of the PSEG EEP sites. Motorized off-road vehicles include, but are not limited to, four-wheel drive automobiles, all-terrain vehicles, motorcycles, dirt bikes, golf carts and snowmobiles.
- Use only designated boat launches.
- Personal watercraft (jet skis) are not permitted to launch at the CRW Site; see *Rules* sign at each site.
- No swimming, camping, fires, fireworks or alcoholic beverages.
- No cutting, removal or damage of natural resources (vegetation, shrubs, trees, flowers, wetland plants) or cultural and historic resources.
- Littering and/or dumping are prohibited. Violators will be prosecuted. Follow “carry-in/carry-out” practices for disposing all trash. Illegal littering and dumping will be investigated and prosecuted.

Site Use Rules (New Jersey Sites) Continued

- Inappropriate use of a sound-producing device is prohibited, as specified by township ordinance.
- Pets must be on a leash in public access areas, as specified by township ordinance. This applies to all parking areas, nature trails, boat launches and beach areas.
- No horseback riding or dog trials are permitted on EEP properties.
- Hunting and trapping shall be conducted in strict accordance with all applicable statutes, regulations and ordinances, including but not limited to the regulations of NJ Division of Fish and Wildlife.
- Driving of deer is prohibited at the Bayside Tract.
- During trapping season, hunting is prohibited in leased trapping areas at the Bayside Tract.
- Only temporary, portable deer stands and tree climbers are permitted on PSEG property; screw-in steps or nails are prohibited. Permanent deer stands, blinds or other structures are prohibited on EEP sites. At the Bayside Tract, all portable stands must be removed within 10 days of the close of the respective hunting season or they will be removed and confiscated.
- For agricultural fields in seed or with standing crops, public use (including birding, hiking, walking and hunting) is excluded.
- Township and/or County Roads within the Bayside Tract are subject to local rules / ordinances.
