DIRECT REGISTRATION SYSTEM (DRS)

PSEG also participates in DRS. This system allows your PSEG shares to be owned and tracked electronically without having a paper stock certificate issued. DRS also allows electronic share transfers between your broker/dealer and your PSEG account at EQ Shareowner Services.

Shareowner Online requires your account number as well as a unique 12 digit Authentication ID that has been assigned to your account. Your Authentication ID will be provided upon request. To request your Authentication ID, go to www.shareowneronline.com and click on "Sign Up Now!" and then click on the box "I do not have my Authentication ID." After receiving your Authentication ID, you will be instructed to create a username, password, and provide an answer to one of the pre-defined security questions. The Stock Information tab of https://investor.PSEG.com provides access to PSEG stock quotes, historical share prices and dividend declarations, an investment calculator, and company financials.
